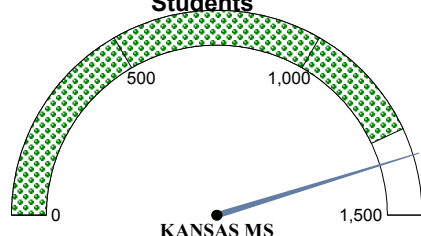


## KANSAS MS

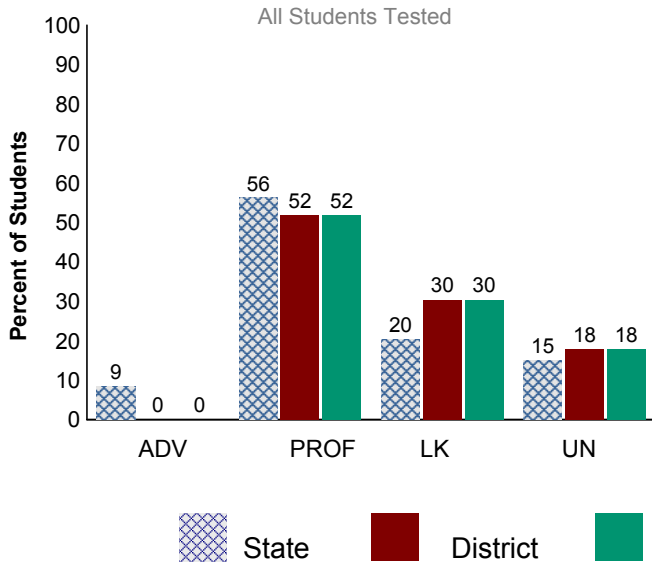

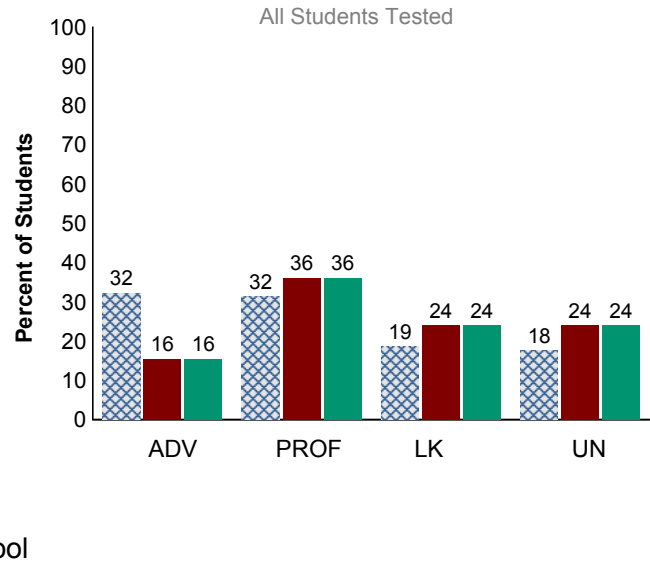

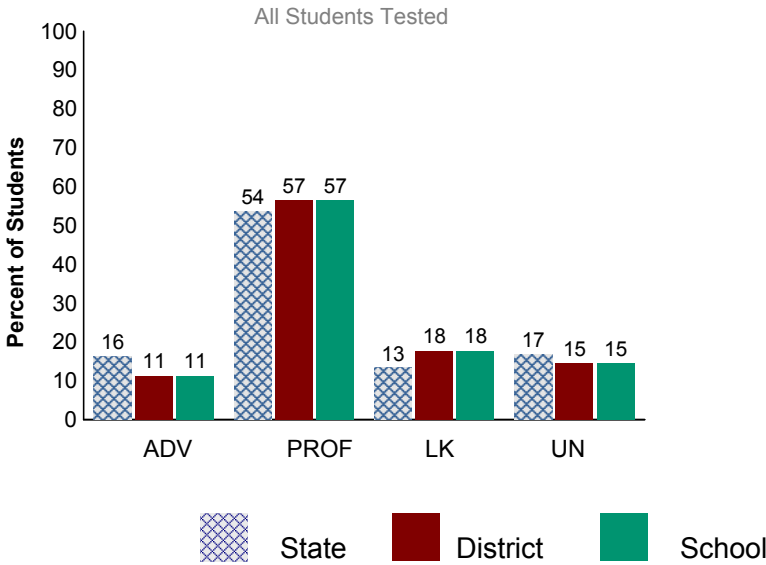

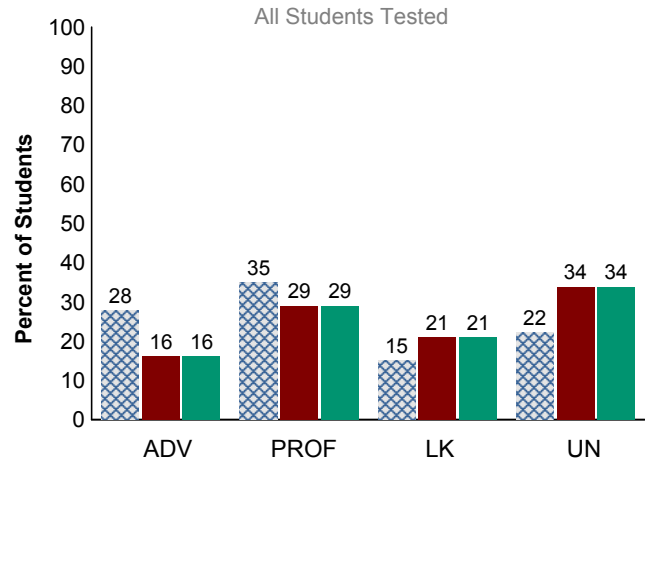

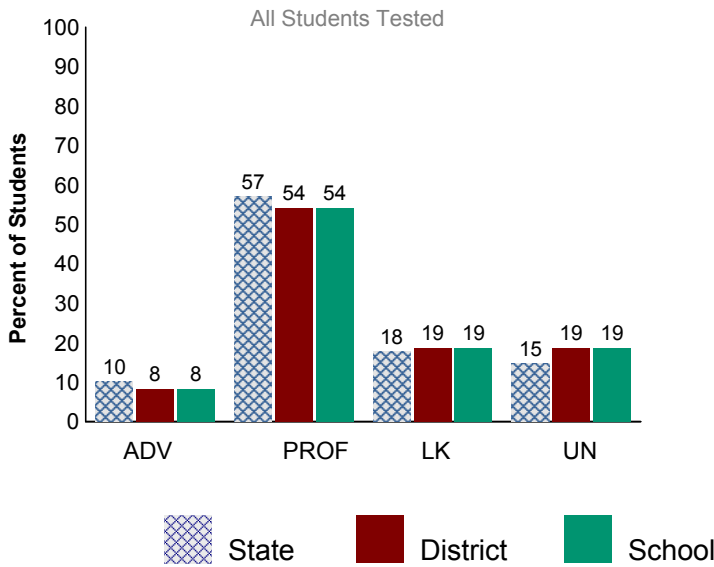

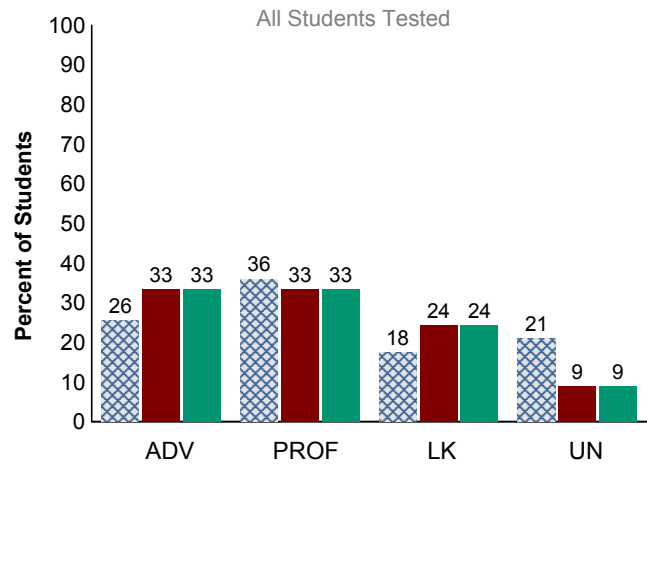
